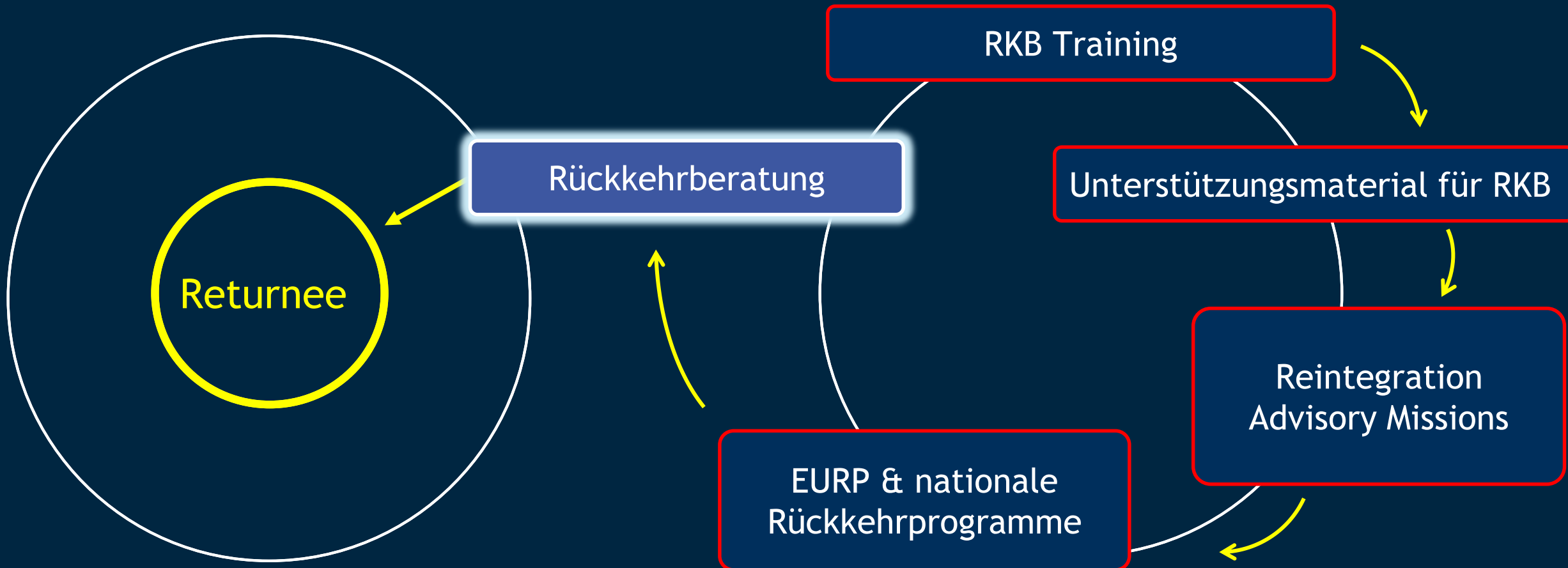

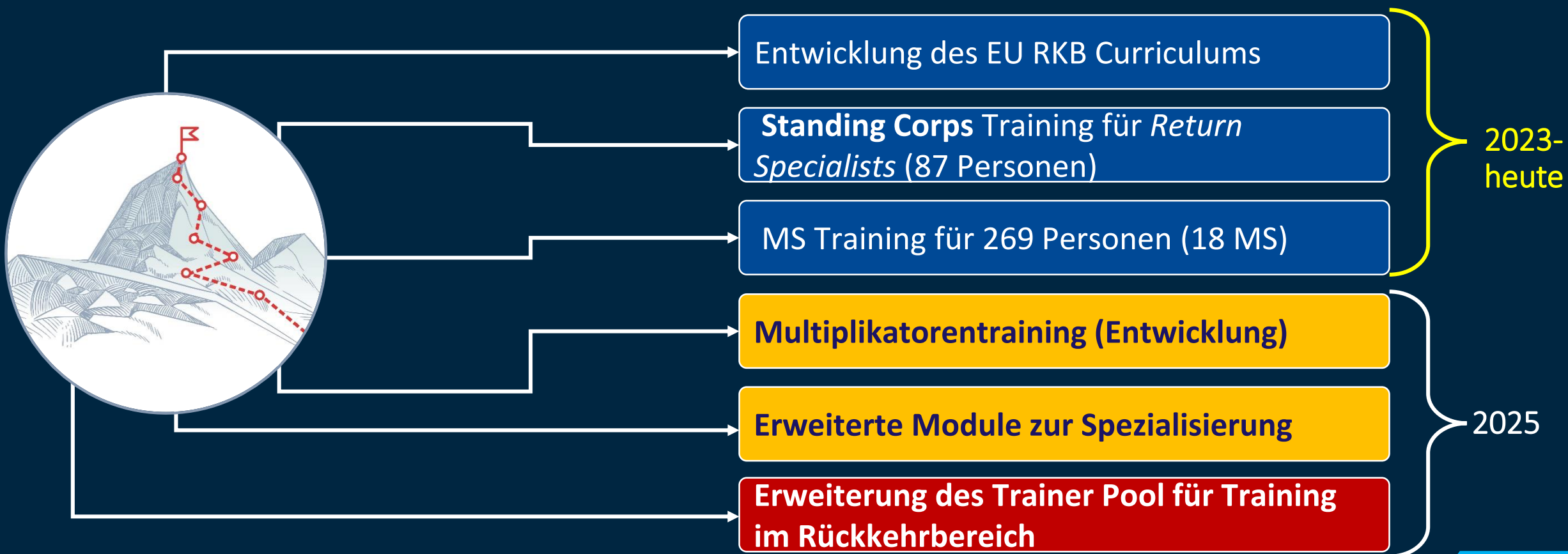

They consist of the provision of pre-departure assistance to irregular migrants on a voluntary or non-voluntary basis from Member States and through Reintegration Centres in third countries of origin, in the case where it contributes to an effective return under the European Union, meaning that returnees are able to acquire and sustain employment, to re-integrate in the country, thereby becoming a productive part of CARITAS INTERNATIONAL BELGIUM in ALGERIA.

Counselling Sessions – Specific Preparations

- Sometimes a specialised caseworker must be involved (e.g. in case of an unaccompanied minor or alleged victims of human trafficking – depending on national requirements and protocols)
- Vulnerabilities – See further under Vulnerable Groups
- A legal Guardian is involved, if necessary
- The security staff must always be informed in case of known behavioural issues or if counselling is done in open or detention centres – see further on the next page.

To steer the conversation effectively, you need to know beforehand what information you need to proceed with the next steps.
